Innforapenny II Sydney Harbour Sailing Day Prize Promotion

CONDITIONS OF ENTRY

1. Information on how to enter and prizes form part of these conditions of entry.
2. Entry into this promotion is deemed to be acceptance of these conditions of entry.

Entry is only open to customers of BackVintage® Wines Australia Pty Ltd (“Promoter”) in New South Wales, Victoria, ACT, South Australia, Queensland, Western Australia, Northern Territory and Tasmania (“Eligible Entrants”). Directors, employees and their immediate families of the Promoter, its suppliers and agencies associated with this promotion are ineligible.
4. No responsibility accepted for late, lost or misdirected entries or correspondence.
5. The Promoter reserves the right to verify the validity of entries and to disqualify any entrant who tampers with the ordering/promotion processes or who acts otherwise than in accordance with these Conditions of Entry.
6. Eligible entrants must have placed an order and paid for one (12 bottle) case of wine from BackVintage® Wines Australia between 9:00 am 26th September 2017 and 5:00 pm AEST 13th November 2017 (Promotion Period) at time of prize draw to claim the prize.
7. Eligible Entrants that place an order(s) must be 18 years of age or over. Tickets or rights for this prize cannot be distributed by or to a person under 18. Nor can a person under 18 dispense or collect this prize.

HOW TO ENTER

8. Eligible Entrants who have purchased one (12 bottle) case of wine from BackVintage® Wines Australia during the promotional period will automatically qualify for one (1) entry into the Prize Draw. Each additional case purchased during the Promotion Period will count as an additional entry into the draw.

Innforapenny II Sydney Harbour Sailing Day Prize Promotion (“Prize”)

- (i) The sailing day comprises sailing and a lunch onboard Innforapenny II – a Lightwave 45' catamaran.
